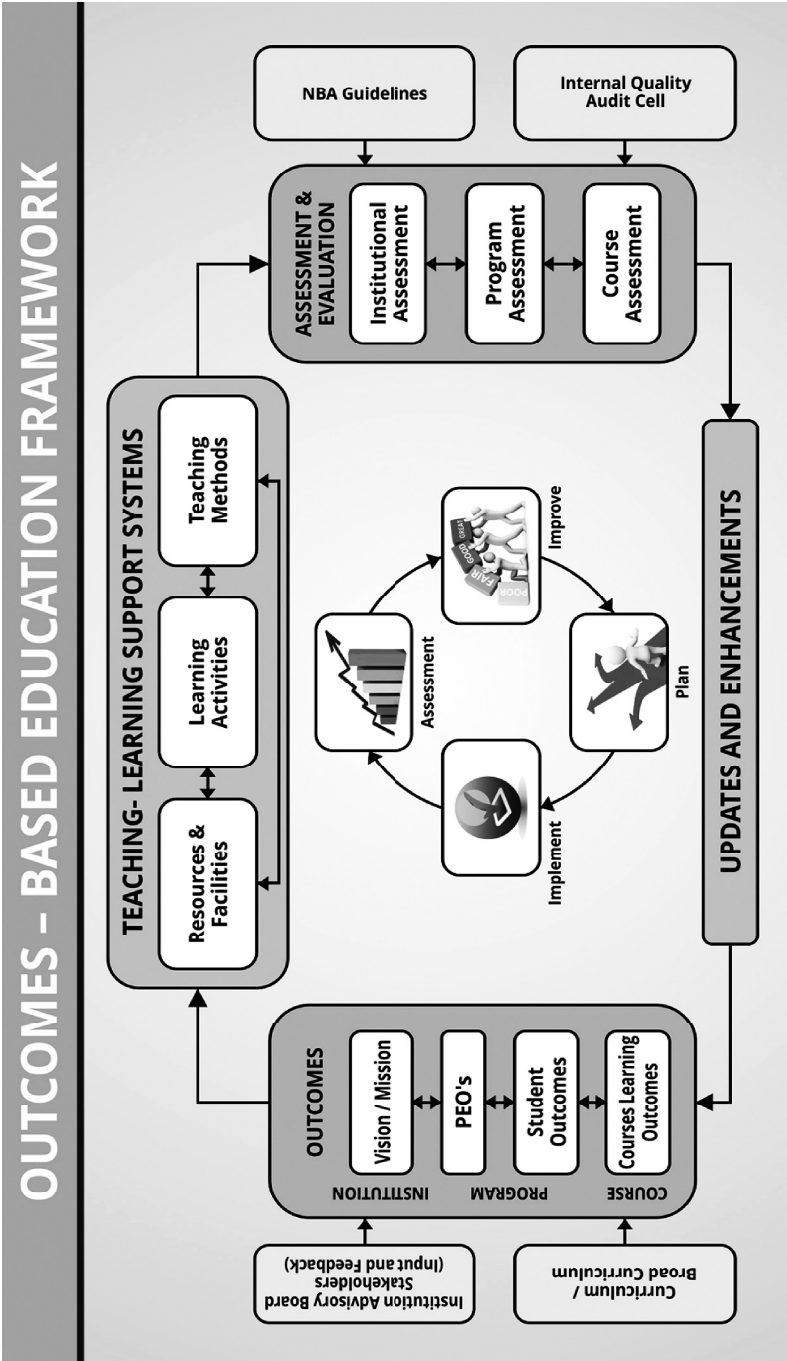

Out of 100 seats, 50% seats will be filled by government & remaining 50% by management as per KSSPCMA guidelines.

#### **Pharm D (30 seats)**

All seats of filled by management as per KSSPCMA guidelines.

#### **M Pharm (15 seats)**

8 seats will be filled by government & remaining 7 seats by management as per KSSPCMA guidelines.

## ELIGIBILITY FOR ADMISSION

### (I) ACADEMIC

#### a) **B. Pharm**

Candidates shall have passed 10+2 examination conducted by the respective State/Central Government authorities recognized as equivalent to 10+2 examination by the Association of Indian Universities (AIU) with English as one of the subjects and Physics, Chemistry, Mathematics/Biology as optional subjects, with 50 % marks in Physics, Chemistry, Mathematics/Biology put together and 50% marks in Mathematics/Biology separately.

#### b) **Pharm. D**

(a) Candidates who have passed Higher Secondary Examination, Kerala or examinations recognized as equivalent thereto, with 50% marks in Biology/ Mathematics separately and 50% marks in Physics, Chemistry and Biology/Mathematics put together are eligible.

OR

(b) A pass in D. Pharm Course with a minimum of 50% marks in D. Pharm examination from an institution approved by Pharmacy Council of India under Section 12 of the Pharmacy Act. (3) Any other qualification approved by the Pharmacy Council of India as equivalent to any of the above examinations.

#### c) **M. Pharm**

A candidate who has passed B. Pharm degree examinations from Kerala University of Health Sciences or an examination equivalent to of any other universities recognised by Kerala University of Health Sciences with not less than a total of 50 % marks for the B. Pharm degree examination shall be eligible for admission to M.Pharm degree course. The candidate should have undergone B.Pharm degree course in an institution approved by PCI.

**(II) AGE**

Applicants should have completed 17 years of age on 31/12/2022. No upper age limit for B. Pharm, Pharm. D & D. Pharm courses.

Copy of relevant page of school record namely SSLC/ CBSE/ICSE certificate showing the date of birth/copy of the birth certificate from appropriate authority should be furnished along with the application.

**(III) NATIONALITY**

Candidates must be a citizen of India.

**(IV) LATERAL ENTRY (B. Pharm)**

Candidates who have passed two year D.Pharm with not less than 50% marks are eligible for admission to the second year of the course.

**(V) FEE STRUCTURE**

As per Govt. directions.

**SELECTION PROCEDURE**

**B Pharm & Pharm. D**

**Preparation of common merit list and allotment of candidates:**

Admissions will be on the basis of marks obtained by the

candidates for Physics and Chemistry in the qualifying examination.

The marks obtained by the candidates in the relevant subjects in the qualifying examination conducted by various boards or authority of other states shall be equated with the marks obtained by the candidates in the same subjects in the qualifying examination conducted by the Director of HSE, Kerala. Marks obtained by the candidates under various streams of examinations such as HSE in Kerala/CBSE/ICSE etc. will be subject to the process of normalisation.

**Explanation:** Under the method of normalisation, the highest mark obtained by students of various boards in each subject shall be equated to the highest mark obtained by the students of the Kerala Higher Secondary Examination in that subject and the relative marks obtained by other students in that subject shall be determined accordingly.

**Illustration:** If the highest marks secured by the student of the Kerala State HSE, in Physics is 100 and the highest mark secured by a student on any other board in the same subject is 90, both the highest marks will be considered to be equal to 100, if a student of the other board secures 60 marks in Physics when the highest mark in Physics in the same board is 90, the 60 marks will be considered to be equal to 66.66 marks as arrived at below.  $100 \times 60/90 = 66.66\%$

Those candidates who have passed the qualifying examination of any state other than Kerala, will be treated at par with those students who have passed the Higher Secondary Exam of this state.

For allotment of D Pharm students to the Pharm D Course, ranklist will be prepared on the basis of the marks obtained by the candidate in the first and second year of D Pharm examination from an institution approved by PCI under section 12 of the Pharmacy act.

**M Pharm****Preparation of common merit list and allotment of candidates:**

Admissions will be done on the basis of the score obtained by the candidate in the GPAT, from among applicants with eligibility in the qualifying examination. Remaining seats will be filled from among the applicants fulfilling eligibility criteria on the basis of marks obtained in the B Pharm course. (Aggregate of II<sup>nd</sup>, II<sup>rd</sup> & IV<sup>th</sup> year B Pharm).

**RESERVATION OF SEATS**

Minority institutions will have the freedom to fix appropriate reservations to their community. Details are available in the respective annexure of the respective colleges.

**FEE CONCESSION**

Fee concession will be given subject to a maximum of 50 % of the fees payable by other regular candidates in the respective Colleges, to candidates whose family income is less than Rs. 100000/- per year. This benefit will be given to a maximum of 3 seats in each course and subject to the passing of all continued examinations and continued good conduct. The Management will have the freedom to verify the family income and if found incorrect appropriate action deemed fit will be taken by the management.

**ADMISSION PROCEDURE****(FOR B. PHARM, M. PHARM & PHARM. D)**

- i. Originals of all certificates/documents enclosed with the application should be submitted at the time of admission to the respective Colleges.
- ii. The candidate shall pay 1<sup>st</sup> year full fee at the time of admission. The fee from Second year onwards shall be paid at the beginning of the respective academic year.

- iii. Physical fitness certificate, conduct certificate and transfer certificate originals should be submitted at the time of admission to the respective Colleges.
- iv. The responsibility of the Association is limited to the publication of the Prospectus, Making notification, Selection procedures, Publication of RankList, Selection memo.

#### **REFUND / ADJUSTMENT OF FEES**

Fees paid will be refunded as per PCI norms. In the case of SC/ST candidates they should remit their first year fee to the concerned college at the time of admission. The same will be refunded in case the Govt. pay the fees to the college or assure the payment of the same.

#### **OTHER INFORMATION**

- i. No request for change of selection processes will be entertained, nor will the association will entertain enquiries with regard to date of publication of the result.

## **PROGRAMME CONTENT AND SCHEME OF EXAMINATION**

### **B. Pharm (PCI Syllabus)**

#### **Duration of the program**

The course of study for B. Pharm shall extend over a period of eight semesters (four academic years) and six semesters (three academic years) for lateral entry students.

#### **Attendance**

A candidate is required to put in at least 80 % attendance in individual courses considering theory and practical separately. The candidate shall complete the prescribed course satisfactorily to be eligible to appear for the respective examinations.

#### **Sessional Exams**

Two Sessional exams will be conducted for each theory / practical course as per the schedule fixed by the college. The average marks of two sessional exams will be computed for internal assessment. Sessional exam will be conducted for 30 marks for theory and will be computed for 15 marks. Similarly sessional exam for practical will be conducted for 40 marks and will be computed for 10 marks.

#### **End Semester Examinations**

The End Semester Examinations for each theory and practical course through semesters I to VIII shall be conducted by the university except for the subjects with asterix symbol (\*) in the table for which examinations shall be conducted by the subject experts at college level and the marks/grades shall be submitted to the university.

### **Criteria for Pass**

For declared to be passed and eligible for getting grade in a course of B. Pharm. program

- A candidate must obtain

- Minimum 50% mark separately for university theory examination in each subject
- Minimum 50% mark separately for University Practical examination in each subject
- Minimum 50% marks for internal assessment in theory and practical separately in each subject.
- Minimum of 50% marks in University theory and internal assessment taken together for each subject.
- Minimum of 50% marks in University Practical, internal assessment and viva voce taken together for each subject

- Those who fails in theory paper of a particular subject and if they pass in the practical of that subject they will have to appear for theory paper of that particular subject only. Those who fails in Practical of a particular subject and if they pass in the Theory paper of that subject, they will have to appear for that particular practical only.

- If the candidate does not fulfill any one of the pass criteria and at the same time secure aggregate of 50% or above (Sessional and End semester theory and practical), the candidate will fail and hence the letter grade shall be “F” and Grade point shall be “0”. The Semester Grade Point Average (SGPA) of a semester shall be awarded only to those candidates who pass all papers in that semester. The Cumulative Grade Point Average (CGPA) shall be awarded only to those candidates who pass the entire course.

### **Criteria For Promotion**

(i) A student shall be eligible to carry forward all the courses of I, II and III semesters till the IV semester examinations. However, he/she shall not be eligible to attend the courses of V semester until all the courses of I and II semesters are successfully completed.

(ii) A student shall be eligible to carry forward all the courses of III, IV and V semesters till the VI semester examinations. However,

he/she shall not be eligible to attend the courses of VII semester until all the courses of I, II, III and IV semesters are successfully completed. He/she shall not be eligible to register for examination of VIII semester until all the courses of I to VII semesters are successfully completed.

(iii) A student shall be eligible to carry forward all the courses of V, VI semesters till the VII semester examinations. However, he/she shall not be eligible to get the course completion certificate until all the courses of I to VIII semesters are successfully completed.

(iv) A student shall be eligible to get his/her CGPA upon successful completion of the courses of I to VIII semesters within the stipulated time period as per the norms specified in 26.

(v) A lateral entry student shall be eligible to carry forward all the courses of III, IV and V semesters till the VI semester examinations. However, he/she shall not be eligible to attend the courses of VII semester until all the courses of III and IV semesters are successfully completed.

(vi) A lateral entry student shall be eligible to carry forward all the courses of V and VI semesters till the VII semester examinations. However, he/she shall not be eligible to get the course completion certificate until all the courses of III, IV, V, VI, VII and VIII semesters are successfully completed.

(vii) A lateral entry student shall be eligible to get his/her CGPA upon successful completion of the courses of III to VIII semesters within the stipulated time period as per the norms specified in 26.

(viii) Any student who has given more than 4 chances for successful completion of I/III semester courses and more than 3 chances for successful completion of II/IV semester courses shall be permitted to attend V/VII semester classes ONLY during the subsequent academic year as the case may be. In simpler terms there shall NOT be any ODD BATCH for any semester.

### **Pharm.D (Doctor of Pharmacy)**

#### **Duration**

The duration of the course shall be six academic years (five years of study and one year of internship or residency) full time with each academic year spread over a period of not less than 200 working days. The period of six years duration is divided into two phases – Phase I – consisting of first, second, third, fourth and the fifth academic year. Phase II – consisting of internship or residency training during the sixth year involving posting in specialty units. It is a phase of training wherein a student is exposed to actual pharmacy practice or clinical pharmacy services and acquires skill under supervision so that he or she may become capable of functioning independently.

#### **Attendance**

A candidate is required to put in at least 80% attendance in individual courses considering theory and practical separately. The candidate shall complete the prescribed course satisfactorily to be eligible to appear for the respective examinations.

#### **Sessional Exams**

There will be at least three sessional examinations during each academic year and the highest aggregate of any two performances will form the basis of calculating sessional marks.

#### **Yearly University Examination**

The university examinations shall be held at the end of each academic year.

#### **Criteria For Pass**

a) Candidate who has secured a minimum of 50% marks in theory (for internal and university examination separately) and 50% marks in practical (for internal and university examination separately) in any subject, shall be declared to have passed in that subject.

b) If a candidate fails in either theory or practical she/he has to appear for both theory and practical of that subject.

#### **Criteria For Promotion To Next Year**

All the students of Pharm. D. course who have registered for all the papers in the annual regular examinations, shall be permitted to attend the classes of the next higher year, on condition that he/she shall have to discontinue the studies in the higher year, if he/she fails in more than two subjects of the lower year even after the 1<sup>st</sup> supplementary examination available for him/her for that particular year.

Explanation: The failed students of regular examinations are eligible to appear for the 1<sup>st</sup> supplementary examinations in the failed papers, and if they pass in the failed papers, they are eligible to continue with the original batch without losing additional six months. However, if the student has more than two failed papers of the 1<sup>st</sup> year, even after the 1<sup>st</sup> supplementary examination, he/she shall have to discontinue the 2<sup>nd</sup> year studies and considered as not promoted to 2<sup>nd</sup> year. A student after first year supplementary examination can carry two or less than two subjects of the first year to the second year and continue with the second year. Failure in more than two subjects shall keep the student with the succeeding regular batch. For promotion to third year the candidate should have cleared all the first year papers and for promotion to fourth year he/she should clear all the papers in the 2<sup>nd</sup> year and so on. Before registering for the fifth year exam, the candidate should have cleared all the papers of the past years. Only after the passing of all the papers including the fifth year the students are eligible for internship. Attendance will be counted for each year from day one only when the candidate is qualified to be promoted to that year.

**M.Pharm****Duration of the program**

The program of study for M.Pharm. shall extend over a period of four semesters (two academic years). The curricula and syllabi for the program shall be prescribed from time to time by Pharmacy Council of India, New Delhi.

**Attendance**

A candidate is required to put in at least 80 % attendance in individual courses considering theory and practical separately. The candidate shall complete the prescribed course satisfactorily to be eligible to appear for the respective examinations.

**Sessional Exams**

Two sessional exams shall be conducted for each theory / practical course as per the schedule fixed by the college. The average marks of two sessional exams shall be computed for internal assessment.

**Criteria for Pass**

If a candidate fails in either theory course or practical course of her/his specialization, she/he has to appear only for the course in which she/he has failed.

If the candidate does not fulfill any one of the pass criteria and at the same time secure aggregate of 50% or above (Sessional and End semester theory and practical), the candidate will fail and hence the letter grade shall be “F” and Grade point shall be “0”. The Semester Grade Point Average (SGPA) of a semester shall be awarded only to those candidates who pass all papers in that semester. The Cumulative Grade point Average (CGPA) shall be awarded only to those candidates who pass the entire course.

**Criteria for Promotion to Next Semester**

A student shall be eligible to carry forward all the courses of I and II semesters till the III semester examinations. However, he/she shall not be eligible to submit the project work (thesis) until all the courses of I, II, III and IV semesters are successfully completed.”

#### **CAMPUS RULES AND REGULATIONS**

Nirmala Campus is proud of its eco-friendly serene and peaceful environment. Defacing any part of the campus is treated as an offence. Students have to abide by the rules and regulations of the college framed in accordance with the norms set by the government, the university and the authorities of the college.

##### **A. BEHAVIOUR AND DISCIPLINE**

Deeply committed to upholding value system, the college expects its students to conduct themselves in a worthy manner in their dress, demeanor and sense of discipline.

- All students are bound to obey the rules, regulations and instructions given by the Principal and maintain the decorum of the institution.
- Students should be prompt and punctual.
- ID card is mandatory inside the campus
- Students must swipe their ID cards to mark attendance while entering and leaving the campus.
- They should be clean and decorous in dress, language and behaviour.
- When a student meets a member of the teaching staff of the college within the campus or outside , it is a matter of politeness that he/she should greet him/ her.

- Students should be seated in their respective classrooms at the stroke of the bell.
- When the teacher enters the class room students must remain standing until they are directed to sit, or till the teacher takes his/her seat.
- When the attendance roll is called, each one must rise and answer to his/ her name or register number.
- Perfect silence should be maintained in the college during class hours.
- Students should keep with them text books and note books required for class they attend.
- Every student must have the prescribed laboratory records, accessories etc. required for the lab.
- No student shall enter or leave a class when a session is in progress without permission of the teacher.
- No student is allowed to go outside the campus without the permission of the Principal during class hours.
- Movements of students in the corridors of the college buildings during lecture hours or sitting on the steps of the staircases is not permitted. Action will be taken against students found loitering about in the corridors and making noise.
- Students are expected to make use of the library during free periods.
- Ragging is prohibited by law. Students shall not indulge in any such activities.
- Smoking, alcoholic drinks, tobacco, Pan parag etc. are strictly prohibited in the college campus.
- Political activity of any kind is banned in the campus.
- Students shall prudently avoid bad company, which leads to failure in study, character and life.
- Use of mobile phones is strictly prohibited in the campus and in the class rooms. Teachers can impound such mobile phones in case of violation.



- Students should maintain a sense of decorum and discipline at all times, both inside and outside the campus. Those who are guilty of serious misconduct or whose presence is detrimental to the order and discipline on the campus are liable to be expelled.
- No member shall throw any waste material on the ground or floor, but shall drop them in the waste baskets and bins provided for the purpose.
- Use of internet by the students in the campus is expected to be for their academic enrichment.
- Separate common rooms and toilets are provided for ladies and gents. They are strongly directed to use only the rooms and toilets allotted for them separately. They can use the rooms allotted for them for taking meals. Class rooms, corridors and stair cases should not be used for that purpose.
- Strict disciplinary action will be taken against students bringing outsiders to the college campus without prior permission of the principal.
- Students are forbidden to organise or attend any meeting in the college campus, circulate any notice or petition of any kind, display posters, banners or boards, use mega phones / loud speakers and paste or write anything in the college campus and premises without the permission of the Principal. No student, on any account, shall make chalk or pencil mark or drawing on walls, black board and furniture.
- Any damage done to college properties will be liable for compensation.
- They are advised to check the college notice board daily.

#### **DRESS CODE**

- The student pharmacist must be in professional attire, which includes clean uniform and identity cards.
- Every student must wear clean lab coats and girls must put up their hair in the practical labs.
- Students are expected to wear their uniforms on all days except Wednesdays.

- Students should avoid wearing tight, transparent or revealing cloths. Sleeveless clothes, round neck T-shirts, and T-shirts with slogans/inscriptions are not allowed. Boys are expected to be in full pants and clean shirts. Low-waisted pants with several large pockets are not allowed.
- Girls are expected to dress modestly. They are not allowed to wear short salwar/kurta. Girls are expected to wear salwar and kameez with dupatta.

#### **B. HOSPITAL WARD ROUNDS: RULES AND REGULATIONS (Pharm. D Students)**

1. Regarding Uniform
  - a) During all ward round college uniform is must.
  - b) Students should wear black shoe.
  - c) Specially designed lab coat should be worn during hospital ward rounds.
2. Strict discipline in hospital.
  - a) No talking during ward rounds with your colleagues.
  - b) Boys to have clean shave with neat hair cutting.
  - c) Girls to put-up the hair.
  - d) Timing for hospital ward round as per time table is to be followed.
3. Case Presentation
  - a) During case presentations maintain strict silence.

#### **C. ATTENDANCE**

- Attendance shall be marked at the beginning of each period by the teacher engaging the period. Late-comers, therefore, though permitted to attend classes by the teacher concerned, will not be given attendance or marked late at the discretion of the teacher concerned.
- Students absenting themselves in any of the class / day for any reason should bring leave letter from their Parents /

Guardians / Wardens mentioning the specific reason for absence and submit the same to the class teacher.

- Attendance is inevitable on the occasions of co-curricular or extra-curricular activities. In case of absence, their parents should report the matter directly to the authorities concerned.
- At the end or the beginning of each month percentage of attendance will be put up on the General Notice Board showing the number of days of attendance lost by each student till then.
- The students are required to put in at least 80 % attendance in individual subjects considering theory and practical separately. Leave application will be considered only if the overall attendance is above 75%.

#### **LEAVE REGULATIONS**

1. A student requiring leave for only an hour or a session must apply for it in writing to the class teacher before the period or session begins.
2. A student requiring leave for a whole day must apply for it in writing to the class teacher in advance and should be attested by parent/guardian/warden.
3. Students who are absent from classes for two weeks or more continuously without written permission of the Principal will be considered to have left the college.
4. Application for sick leave for more than three days should be supported by a medical certificate.
5. Application for leave of absence may be rejected by the Principal/ teacher, if its genuineness is not satisfied.

#### **D. EXAMINATIONS**

1. Students should have a minimum of 80 % attendance in theory and practical subjects separately in order to appear for the university examinations.

2. Uniform is must on all examination dates.
3. Students must attend all sessionals examinations.
4. Students should enter the examination hall
  - a) 15 minutes before the starting of sessional examination.
  - b) 45 minutes before the starting of University examination.
5. Students are not allowed to leave the examination hall before the stipulated time.
6. Exchanges of scale, pencil, erasers etc. are not allowed in examination hall.
7. Malpractice of any kind will be seriously dealt with.
8. Bringing mobile phones to the examination hall will be considered as malpractice.
9. Students involving in any kind of malpractice will not be allowed to write further examinations.
10. The names of those involved in malpractice will be displayed in the notice board.

**E. GENERAL RULES FOR LIBRARY**

1. Students should follow the library rules.
2. Students should swipe their ID cards at the library counter while entering & leaving the library.
3. All the students are entitled to use the library for reference and for taking books on loan.
4. Strict silence should be maintained in the library and its premises.
5. User's personal belongings are not allowed to be taken inside the library.
6. One student can take 2 books on loan at a time. Book should be returned on or before the date stamped last on the book.

7. Reference book will not be lend out but they may be referred in the library.
8. For issuing book form library, college ID card and library card should be submitted along with the book taken. (For entering in to campus 7 software)
9. Readers will be responsible for any damage caused to books or any other property. Those who damage books, shall be fined in proportion to the damage. To be safe, when a book is issued to a reader, he/she must point out to the librarian any defect noted concerning the book. Lend books should be kept in good condition.
10. Students are not allowed to sub-lend the library books.
11. Students shall not engage in conversation in any part of the library so as to cause annoyance to any other reader.
12. Students shall not write upon, damage or mark any book belonging to the library.
13. Upon any infringement of the library rules members shall forfeit the privileges of use and membership of the library.
14. The students caught tearing pages/ stealing of books will be suspended forthwith from using the library facilities and the college will initiate further disciplinary action against them.

#### **LOAN OF BOOKS**

1. Members are eligible for borrowing books from the library as follows:-
  - a) Students - 2 Books
  - b) Teaching Staff - 8 Books
  - c) Non teaching staff - 2 Books
2. The loan period of books is generally 10 days. Books should be returned on or before the date stamped last on the book. If the due date happens to be a holiday, books need to be returned only on the next working day.

3. A book will be issued to the member against production of borrower's card with the I.D. card, failing which the library staff can refuse to issue books to him/her.
4. An overdue charge of Rs. 1/- per day per volume shall be collected as fine for the first 10 days and thereafter Rs. 5/- per volume per day shall be levied.
5. The librarian reserves the right to recall any book from any member at any time.
6. The librarian may shorten the loan period if the books are on special demand.
7. Books loaned may be renewed for further period provide no other reader has reserved the same.
8. The members are responsible for the library borrower card issued to them. Loss of borrower card should be reported to the library immediately.
9. If any overdue fine amount exist, must be cleared at each end semester/year before the commencement of University Exam.

#### **F. FEE REGULATIONS**

1. The fee shall be paid for the full year on the day of admission or before the last date. Fee once paid will not be refunded.
2. Absence with or without leave from the college shall not be an excuse for non-payment of fee on the prescribed date.

#### **G. MOBILE PHONES ARE BANNED INSIDE THE CAMPUS**

In reference with Govt. circular No. 30115/K3/09/ H.Ed. Dept, mobile phones are strictly banned inside the campus.

#### **H. PREVENTION OF RAGGING IN EDUCATIONAL INSTITUTIONS**

##### **Kerala Prohibition of Ragging Act 1998**

“Students found ragging directly or indirectly or abetting inside or outside an educational institution are liable for imprisonment for a term which may extend upto 2 years with a fine which may be

upto Rs. 10000 .Depending upon the severity of the case, the guilty can be either suspended or dismissed and can also be debarred from gaining admission in any institution for five years”.

**(1) Definition**

“Ragging” means display of disorderly conduct, doing any act which causes or is likely to cause physical or psychological harm or raise apprehension or fear or shame or embarrassment to a student in any educational institution and includes :-

- a) teasing, abusing of, playing practical jokes on or causing hurt to such student,
- b) asking the student to do any act or perform something which the student will not in the ordinary course willingly do.

**(2) Prohibition of Ragging**

Ragging inside or outside the educational institution is prohibited.

**(3) Penalty for Ragging**

Whoever directly or indirectly commits, participates in, abets or propagates ragging inside, or outside, the educational institution , shall, on conviction ,be punished with imprisonment for a term which may extend to 2 years and shall also be liable to a fine which may extend to ten thousand rupees.

**(4) Dismissal of Student**

Any student convicted of an offence under section 4 shall be dismissed from the educational institution, and such student shall not be admitted in any other educational institution for a period of three years from the date of the order of such dismissal.

**(5) Suspension of Student**

(1) Whenever any student or, as the case may be, the parents or guardian or a teacher of an educational institution complains, in writing, of ragging to the head of the educational institution, the head of that educational institution shall, without prejudice to the foregoing provisions, within seven days of the receipt of the complaint , enquire in to the matter mentioned in the complaint

and, if, prima facie, it is found true, suspend the student who is accused of the offence , and shall, immediately, forward the complaint to the police station having jurisdiction over the area in which the educational institution is situated for further action.

(2) Where, on enquiry by the head of the educational institution, it is proved that there is no substance prima facie in the complaint received under sub-section(1), he shall intimate the fact, in writing, to the complainant.

**(6) Abetting**

If the head of the institution refuses to take action in the manner described under section six or is negligent in initiating any steps ,he is to be treated as one abetting the crime and is liable to be punished under section four. As per the orders of the Hon’ble Supreme Court of India, ragging in educational institutions is a criminal offense. In order to implement the Supreme Court orders, an anti-ragging cell has been constituted in our college and any complaints regarding ragging may immediately be brought to the notice of any of the members of the cell.

**ANTI-RAGGING SQUAD**

Anti-Ragging Squard is constituted, consisting of the following under Regulation 6C of the said AICTE Regulation 2009 to maintain vigit, oversight and Patrolling function and shall always remain mobile, alert and active throughout to ensure that not a single incidence of ragging creeps in the College or Hostels or anywhere and will adopt such measures as may be necessary to crub the menance of ragging

#### **TRAINING AND PLACEMENT CELL**

Besides the knowledge in academic subjects overall

development of a student is an essential thing in moulding the student to an employable person. The job opportunities is diversified now. The graduates can start their career as a clinical or community pharmacist or they can get exposed to sophisticated jobs like clinical data management as medical writers. Another promising field is getting employed in production, research, quality analysis, quality assurance etc. Another option of students is to get enrolled in post graduate specialisations like M.Pharm, MBA, Post Baccalaureate Pharm D, PG Diploma in Clinical Trials.

Training and Placement Cell is offering mentoring services to students to focus on their interests. They are given proper guidance and information of career aspects like Production Executive, Quality Analyst, Research and Development, Marketing, Pre Clinical Trials, Clinical Trials, Remote Pharmacist, Medical Writing, Medical Transcription etc. Students are given opportunity for interaction with Qualified Faculty from Industries and Research Organisations to mould themselves with the desired job. For the purpose of identifying their interests we have collected data from among students and have introduced a Placement book. According to the preferences in the data on-campus/outside placements are scheduled. For attaining the goals, students are given training programs which ensure the development of Personality and Communication Skills.

Students interested in pursuing higher studies are given training session and mock tests for National level Pharmacy aptitude test like Graduate Pharmacy Aptitude Test (GPAT). Students are also exposed to online (GPAT) mock tests conducted by national organisations. Our institute organises seminars by Eminent Academicians from Foreign Universities for the students to acquaint about their possibilities for higher studies abroad. Students are also allowed to participate in International Educational Exhibitions to familiarize the procedures for filing towards immigration to the foreign countries for higher studies.
