ORDER

1.Kerala University of Health Sciences, Thrissur vide Notification No.25494/AC1/GEN A2/2019/KUHS dated 04.08.2021 invited applications from various colleges for granting Continuation of Provisional Affiliation to courses under it for the Academic Year 2022-23. The following Pharmacy colleges applied for the same with required fee. The applications were processed by the University and the scrutiny committee scrutinized the inspection reports.

4. The whole matter was placed before the Governing Council for appropriate decision. Accordingly, the decisions of the Governing Council vide paper read (2) as detailed below,

i. The Governing Council resolved to grant Continuation of Provisional Affiliation to the Pharmacy Colleges mentioned in Table A and Table B to the courses for which the intake is recommended again, subject to the approval from PCI for the Academic Year 2022-23 based on the recommendations of the Scrutiny Committee.

5. Sanction is hereby accorded to grant Continuation of Provisional Affiliation to various Pharmacy Colleges for the Academic Year 2022 - 23 as per the tables above, subject to the conditions mentioned below:

- Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- Affiliation granted is strictly provisional and only for the academic year 2022-23. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
- The College should remit annual administration fee fixed for UG/ PG courses for the academic year 2022-23.
